Time of your set-up _____ Your set-up time and hall rental must run consecutively. Example- Hall Rental 5:00 pm Set – Up Noon – 5pm

The hall is always set up for 112 people. You may rearrange the tables and chairs, however, prior to leaving, please return the chairs and tables to their original place. Your rental must end by 12:00 . (midnight)

Prior to signing please read the following rules that apply to all applicants:

1. The hall must be left in good condition by clearing all debris from tables and placing the debris in the provided trash containers. Please remove all of your decorations and lock all doors. Remember to put the tables and chairs in their original place.
2. People responsible for the rental agreement must be at least 21 years of age and the responsible person is in attendance at all times.
3. All decorations must be flame retardant. We ask table candles to be in glass or nonflammable containers. We ask you to not decorate the walls. Do not use staples, nails, thumbtacks or pins anywhere in the hall. You may use painters tape to secure your decorations.
4. There is no smoking in the hall. When smoking outside please use provided containers for cigarette disposal.
5. There will a refundable security deposit of \$50.00. This will be returned by mail immediately after the rental hall has been inspected and found to be in good condition. If you cancel your rental after payment has been made, you will receive a refund equal to 50% of your rental payment.
5. Renter agrees to hold the Friends of Old St. Ferdinand and their property, including the facilities, free and harmless from any and all liability for injury to or death of any person in attendance at the event that is requested on this form.
